

Privacy Notice

This Notice takes effect on [10.9.2025]

This Privacy Notice aims to give you information on how [MRS]("we", "us", or "our") collects and processes your personal data through your use of this [SightSim]("App" or "Service"), including any data you may provide through this App. By using our Service, you acknowledge that you have read and understand the information in this Notice.

Part 1. Utilization of collected data

Data furnished by you shall be used to provide you with desired Service as requested by you. We use your personal data to improve our App and Service; administer our App; resolve disputes; troubleshoot problems; help promote a safe service; measure user interest in our App, inform you about updates; customize your experience; detect and protect us against error, fraud and other criminal activity; enforce our terms and conditions; and as otherwise described to you at the time of collection.

Part 2. Personal data we collect

We process different kinds of personal data:

- behavioral usage of the App.
- email address.
- the type and operator of network (such as Mac address).
- device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- the type, version, brand, language and operating system of device.

Part 3. Sharing of collected data

We may share personal data with:

- our third-party service providers and vendors, such as IT support, hosting, data processing, user service, and related services.
- our business partners to provide you with the Service you have requested.
- parent or subsidiary companies to coordinate and manage our business.
- to comply with law enforcement, regulatory, or national security requests and legal process, like a court order or subpoena

Part 4. Children

Our Services are not directed to children under 13 (or other age as required by local law). We do not knowingly collect personal information from children. If you are a parent or guardian and believe your child has uploaded personal data to our App without your consent, you may contact us.

Part 5. Data subject rights

As a data subject, you may have the right to:

- Request access to and portability of your personal data.
- Request deletion, anonymization or blocking of personal data including when processing is based on your consent, or when processing is unnecessary, excessive or noncompliant.
- Request correction of your personal data where it is inaccurate, incomplete, or outdated.
- Withdraw your consent to our processing of your personal data. Please note that your withdrawal will only take effect for future processing and will not affect the lawfulness of processing before the withdrawal.

Part 6. Security

We make reasonable efforts to protect your data by using physical and electronic safeguards designed to improve the security of the data we maintain.

Part 7. Retention

We keep the personal data for as long as you use the App, or as necessary to fulfill the purpose(s) for which we collected it. There are also other reasons why we may keep personal data. They may include, but are not limited to, resolving disputes, establishing legal defenses, conducting audits, pursuing legitimate business purposes, for trust and safety purposes, and complying with applicable laws.

Part 8. Third-party Services

The App may include links to third-party websites, plug-ins, applications, services, products, and technology ("Third-party Services"). Clicking on links to and using Third-party Services may allow third parties to collect or share your personal data. We are not responsible for the content, security or privacy practices of those Third-party Services and this Notice does not apply to your use of Third-party Services.
